

COVID-19 vaccination certificate for overseas travel

Nishinomiya City will issue the “Vaccination Certificate of COVID-19” (Vaccine passport) so that one may receive eased epidemic prevention measures upon entering other countries when traveling overseas.

【The start date of accepting applications and issuing the certificates】

July 26 (Mon), 2021

【Eligible person】

A person who has his/her resident registration in Nishinomiya City at the time of COVID-19 vaccination and needs the vaccination certificate for overseas travel (Vaccine passport).

** Within Japan, the “Certificate of Vaccination for COVID-19” attached to the vaccination coupon can be used as the certificate.

【Necessary documents for application】

◆ People who want to apply at the City Hall counter will need to bring the documents (1) – (4) listed below.

----Copies are accepted for (2) and (4)

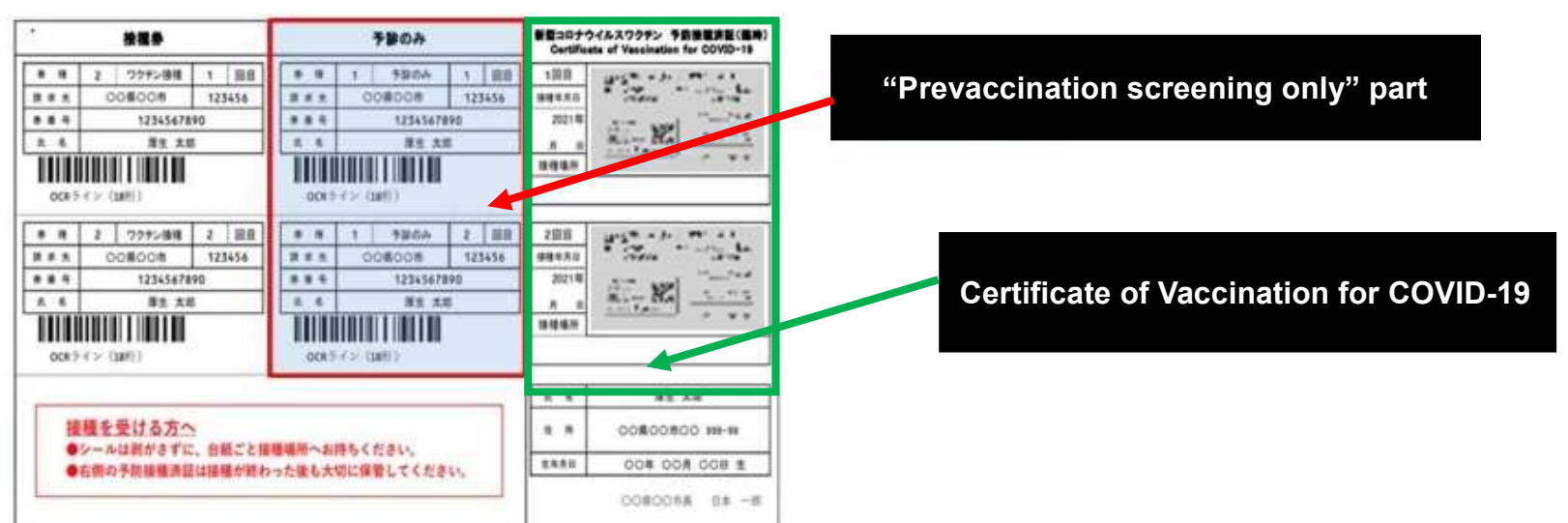
◆ People who want to apply via mail will need to send the documents (1) – (5) listed below.

---Submit copies for (2), (3), and (4)

(1) [Application Form for Vaccination Certificate of COVID-19](#)

(2) Passport

(3) The “Prevaccination screening only” part and the “Certificate of Vaccination for COVID-19” of the vaccination coupon. ** As for healthcare workers etc., submit the record of vaccination.



(4) The identification document (ID) with the address of the claimant written on it.

(5) Return envelope (Please write the return address and name, then be sure to put stamps on the envelope)

<Note> ** In order to put a birth name, alternative surname, or alias name which is not written on the passport, it is necessary to show an ID with the birth name, alternative surname, or alias name on it.

** When a proxy will apply, following documents will be necessary in addition.

- ① Letter of proxy
- ② ID of the proxy

【Place for application and where to send the application】

◆ **Place for application (application at the City Hall counter)**

【Hours】 9:00 am – 5:00 pm (excluding Sat, Sun and holidays)

** When all the necessary documents are submitted, the certificate will be issued immediately, in principle. However, if there are some lacking documents, it may take about 2 weeks until the issuance.

◆ **Where to send the application (application by mail)**

** If there are no errors on the matters written on the application form, Nishinomiya City will send the certificate to the address written on the return envelope.

** After receiving the application form, it will take approximately 2 weeks until the issuance of the certificate.
