

Special Benefit for Supporting Low-income Families with Children
(for households other than single-parent households)

**This information is for people
“who need to apply to receive the benefit”**

● Eligible persons (need to fill both conditions ① and ② below)

① Parents or guardians who are raising children born between April 2, 2004 and Feb 28, 2023

※ For children with disabilities (who are eligible for Special Child-rearing Allowance), born between April 2, 2002 and Feb 28, 2023

② Those who are exempt from resident tax (per capita levy part) or those facing a sudden drop in income due to COVID-19 after Jan 1, 2022 and now only have **income equivalent to the level to be exempt from resident tax.**

If you meet any of the following, you need to apply.

① A civil servant who is receiving child allowance for Apr 2022 from his/her workplace

② A new recipient of Child Allowance from May 2022 to Mar 2023

③ A new recipient of Special Child-rearing Allowance from May 2022 to Mar 2023

④ Parents and guardians raising only children who finished junior high school as of Mar 31, 2022. (Children born between Apr 2, 2004 and Apr 1, 2007)

Households receiving Child Allowance, or Special Child-rearing Allowance for Apr 2022 and also exempt from resident tax (the per capita levy part) **do not need to apply.**

● Amount of benefit	Flat rate of 50,000 yen for each eligible child
● Term of application	From Jun 24, 2022 – Feb 28, 2023 (must arrive by this date)
● Time of payment	Starting from the end of July, 2022, then in sequence ※ After the examination of application, the result will be notified by the notice of payment determination.

For those who need to apply
It is necessary to fulfill both **【child-rearing requirement】**
and **【income requirement】** written below

【Child-rearing requirement】

- ① A civil servant who received Child Allowance for Apr 2022 from his/her workplace
- ② A child born between Apr 2022 and Feb 28, 2023 who is a new recipient of Child Allowance from May 2022 to Mar 2023
- ③ A new recipient of Special Child-rearing Allowance from May 2022 to Mar 2023
 ※ Special Child-rearing Allowance (targeted for children with mental or physical disabilities who is under 20 years of age)
- ④ Parents and guardians raising only children who finished junior high school (Children born between Apr 2, 2004 – Apr 1, 2007)
 ※ Excludes anyone who received Special Child-rearing Allowance for Apr 2022

【Income requirement】

Those who were not originally exempt from resident tax (per capita levy part) in 2022, but due to a sharp decline in income after January 1, 2022, now are at the income level equivalent to persons who are exempt from resident tax.

(Note) Number of persons in a household includes the following;

- The applicant him/herself
- A spouse living in the same household (and whose income last year was less than 1,030,000yen.
- Dependents (including children under 16 years of age)
