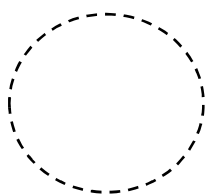

- ② If confirmation is not possible by means such as public records, you may be asked to submit relevant documents. Confirmation of the residences in other municipalities may also be checked.
- ③ If the municipality cannot make the payment due to discrepancies in the bank account details submitted below, and if the municipality cannot contact or confirm the head of the household (applicant/recipient) or a proxy within the application period, the municipality shall deem the said application to have been retracted.
- ④ If, for any reason, household members other than the head of the household recorded on the Basic Resident Register are found to have received the Special Cash Payments for Newborn Babies in duplicate, or if the municipality confirms that the eligible person does not live in the place of residence, they will be obliged to return it.
